

BID NOTICE

EAST RUTHERFORD BOARD OF EDUCATION BERGEN COUNTY, NEW JERSEY

PLEASE TAKE NOTICE that sealed bids for a contract for the **East Rutherford Referendum Projects; AS Faust Middle School Addition, AS Faust MS Renovations, AS Faust Annex Renovations, and McKenzie School Renovations**, for the East Rutherford School District will be received by the Business Administrator of the **East Rutherford Board of Education** (“Board”), or her designee, on **Friday, January 22, 2021, at 2:00 p.m.**, prevailing time, at the Business Administrator’s Office located in the Faust Middle School, 100 Uhland Street, East Rutherford, New Jersey 07073, at which time said bids will be publicly opened and read.

All bids must be on the proposal forms obtained from the Board’s Architect. All bids must be enclosed in a sealed envelope bearing the name and address of the bidder and the words “Sealed Bid – East Rutherford Referendum Projects: 3651,3652, 3653,3656”. The envelope must be addressed to Business Administrator, East Rutherford Board of Education, 100 Uhland Street, East Rutherford, New Jersey 07073, and may be delivered by hand, overnight courier or mail. The envelope containing the bid must be received by the Business Administrator by the date and time set forth above. No late bids will be accepted.

The bidding documents will be available on **Wednesday, November 25, 2020**. Prospective Bidders can preview and purchase the full bid package (cost \$500) directly from the Architect’s website: **www.dicararubinoplans.com**. Any contractor submitting a bid must be listed on the official bidders list. Any bid received from a contractor that is not a listed plan holder will be rejected. **No documents shall be mailed, via US mail or overnight mail.**

There will be a pre-bid meeting on **Friday, December 11, 2020 at 10:00 a.m.** *The Meeting will commence at the Faust Middle School located at 100 Uhland Street, East Rutherford, NJ 07073.* All bidders are strongly encouraged to attend the Pre-Bid Meeting.

Each bid must be accompanied by a certified check, cashier’s check or bid bond from a surety company licensed to do business in New Jersey, in the amount of ten percent (10%) of the base bid submitted, but not in excess of \$20,000.00, made payable to the East Rutherford Board of Education.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27.

The Board reserves the right, in accordance with applicable laws, to waive any minor irregularities in or to reject any or all bids. By order of the East Rutherford Board of Education.
